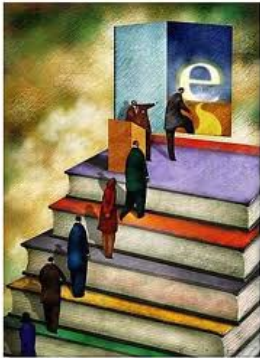




Ebook Primer



It's short for electronic book, and you may see it typed as: Ebook, eBook, e-book, eBOOK, ebook, and digital book. An e-book is defined by Merriam-Webster as "a book composed in or converted to digital format for display on a computer screen or handheld device." We will be using "ebooks" as that is easiest to type!

Ebooks should not be confused with audiobooks. Audiobooks are books that have been recorded by the author or a professional voice (think of the old *Books on Tape*). While some ebooks have voice-capability, the voices are computer-generated and not human voices.

Physical books come in different flavors: library reinforced bindings, hardcovers, paperbacks, rebound books. So do ebooks. There are subscription ebooks, single-license ebooks, unlimited, simultaneous license ebooks, metered ebooks, permanent-license ebooks; almost as many types of Bubba Gump shrimp!

A key difference between books and ebooks is that when you buy a book, you own that book. You can lend or give it to a friend. You can sell the book. You can cut pages out and decorate your room. When you buy an ebook, you own the license; you can never own an ebook. But there is an exception: public domain ebooks. See below.

You are not allowed to transfer the license to anyone. You are not allowed to sell the license to anyone. Depending upon the license, you may not even be allowed to print the entire book.

Ebooks can be a subscription service, such as *TumbleBooks*. These ebooks can only be read online, meaning you must be connected to the Internet. This may be considered a disadvantage, but subscription services usually allow a large or unlimited number of simultaneous users. So if you have 35 computers in a lab, you can have all 35 reading the same ebook at the same time. You don't own the ebooks; if you don't renew the subscription, you lose access to the books. You cannot download these ebooks to a computer or other device. Some publishers, like Lerner and Capstone have similar ebooks, but once purchased, the license does not expire.

Other ebooks are individually purchased. The ebook may be downloaded to a computer. The ebook may then be read anywhere; an Internet connection is not needed. They work just like physical books; you must purchase as many electronic copies as you want to circulate. So if you purchase one copy of an ebook title, you can only have one person at a time reading that copy. When checked out, a copy is not available for anyone else to read that copy online or to check it out.

For consumers buying their own personal ebook, you are normally allowed to install the ebook on up to six devices, depending upon the publisher and seller (like Amazon). Public libraries and educational institutions are not given that option.

Many ebooks have a digital rights management system, so they may require proprietary ereaders. Non-proprietary ebooks may use Adobe Reader or any application that will read PDF files. Follett ebooks use their own app and won't work with any other ereaders, although Follett is providing apps for more different devices. OverDrive has an app for just about any and every reading device, from kindles to smartphones.

Free ebooks: Project Gutenberg (<http://gutenberg.org>) offers public domain (copyright-free) ebooks; these are titles whose copyright has expired, meaning they are older than 75 years. These are your "classics," such as titles by Shakespeare, Mark Twain, Sir Arthur Conan Doyle, and Jane Austen. OverDrive also allows access to Project Gutenberg titles.

Ebook costs are comparable to physical book pricing, even though there are fewer production costs, and shipping and handling costs, storage costs, and such. The publishers hold the keys to the kingdom and they aren't letting go. Authors, the creators of the content, aren't getting much more than before, but that may be changing slowly. Unlimited, simultaneous-use licenses can cost two to four times the cost of an individual ebook. They are almost never offered for public libraries, but may be available from school library vendors, such as Follett.

Self-published ebooks (we used to call them "vanity publishers" when they printed books) are becoming more common. Not only can you publish your own book, but you can market and sell them yourself through vendors like Amazon. The quality and your mileage may vary.

These are \$40 per title and are unlimited, simultaneous-use, and permanent licensing.

Follett Shelf ebooks

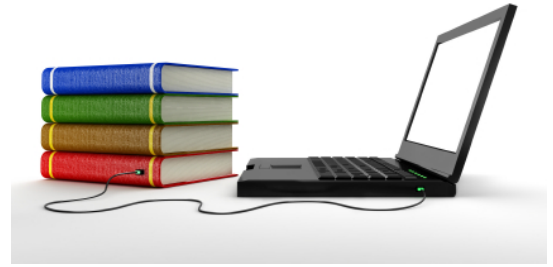
Follett Shelf ebooks may be read online as a preview, checked out, and then either read online or downloaded. The default checkout time is two weeks. In



Follett Shelf, an ebook may be previewed online, which shuts off access to the ebook to others. When the ebook is "closed," others may access the ebook.

Once an ebook is checked out, it will not be available for checkout, or to be read online, until the user returns the book or the checkout period expires.

Patrons must have a Destiny Username and Password (for the site that has the eBooks) in order to check out eBooks to read online or to download. All APS patrons have the ability to create their own Destiny account as long as their Last Name and Barcode (District ID) number, and Date of Birth (students only) is already in the system. Click *Login*, then the *Create New Accounts* tab. Follow the online prompts to create a Destiny account. You can download a PDF help sheet here:

Ebooks can be “Read Online” without a Destiny account, but only as a preview, and cannot be checked out, or use any of the features available (notes, bookmarks, etc.).

OverDrive is leveled into three areas: Adult (grades 9 and up), Middle School (grades 6-8), and Elementary (grades P-5). All patrons can see all eBook titles. They can also read a sample of all eBook titles. However, patrons can only check out eBooks at their assigned level.
